PERPETUAL STREET EASEMENT

THIS EASEMENT AGREEMENT ("Agreement") is made and entered into effective as of the 25thday of August 20_25, by and between Mabank Independent School District, a political subdivision of the State of Texas ("Grantor"), and City of Mabank, a Texas home-rule/general-law municipality ("Grantee").

RECITALS

- 1. Authority. Grantor is the fee simple owner of the property described herein and is authorized under Texas Education Code § 11.154 to convey an interest in real property by easement for public purposes.
- 2. Public Purpose. Grantee desires to use the easement for the construction, maintenance, operation, and repair of public streets and related public infrastructure, serving the public and benefiting the Grantor's property.
- 3. Board Approval. The Board of Trustees of Grantor has determined that the easement described herein is not needed for school purposes and that granting it to Grantee for public street purposes serves a public purpose.

AGREEMENT

- 1. Grant of Easement. Grantor hereby grants, sells, and conveys unto Grantee, its successors and assigns, a perpetual, non-exclusive easement (the "Easement") across the land described in Exhibit "A" attached hereto and incorporated herein for all purposes, for the purpose of constructing, reconstructing, operating, maintaining, repairing, replacing, and using public streets, sidewalks, utilities, drainage, and associated public infrastructure.
- 2. Use of Easement. The Easement shall be used solely for public right-of-way purposes, including vehicular and pedestrian travel, and the installation of related street improvements, utilities, and appurtenances customarily located within public rights-of-way.
- 3. Maintenance. Grantee shall, at its sole cost, maintain the Easement area in good condition, free of hazards, and in a manner consistent with municipal street standards.
- 4. Ownership. Grantor retains fee simple title to the land subject to the Easement, together with the right to use the Easement area for any purpose not inconsistent with the rights herein granted.
- 5. Binding Effect. This Easement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
